- 1) The meeting was begun with a prayer by Bob M, Church Clerk, and was then called to order by same.
- 2) <u>Determination of Quorum</u> Browncroft Community Church has 759 active members. A quorum based on 1/5th required 152 members to be in attendance. The quorum count was 177.
- 3) <u>Election of Tellers</u> Robert Morse, Church Clerk, asked for a motion to approve Kristen Schmidt, Kevin Hill, and Laura Mathias to act as Tellers for the meeting. A call to the congregation for additional tellers resulted in Patsy Morse offering to serve as a teller. The motion to approve these individuals as tellers received a first, was seconded and carried unanimously.
- 3) <u>Election of Presiding Officer</u> In accordance with our By-laws, Sam Huey, as Elder Chairman, is the standing nominee for the presiding officer of the meeting. <u>MOTION</u> to elect Sam Huey as the presiding officer of the meeting was carried with 3 opposed after a first motion, and then a second, were received.
- 4) Approval of Minutes Copies of the October 12, 2021 and December 5, 2021, Congregational Meeting Minutes were handed out at the meeting and included in the website portal. The Chair asked if there were any corrections or comments. Hearing none, the minutes were approved unanimously following a first motion with a second.
- 5) <u>By-Laws Proposal</u> Motion: Resolved that the proposed Browncroft Community Church bylaws revision last edited on September 16, 2022, is approved and implemented as documented.

Sam Huey and Sherwin Damdar provided a history of the By-Laws and a detailed rationale for these changes. Two townhall meetings were held in September to allow members of the congregation to ask questions regarding these changes. The Chairman allowed members to come forth to make comments and to ask additional questions. Following a detailed discussion, a motion was made to call to question by Sherwin Damdar. A first and second motion was received, and it passed unanimously.

A two thirds vote is required for this motion to pass. The final vote is as follows:

Total yes votes 122
Total no votes 51
Abstentions 4

This vote passed.

- 6) <u>Election of Officers</u> Sam Huey reviewed the qualifications of Elders and other Church Officers, and then presented those who had been interviewed or reaffirmed by the Church's Personnel Team and approved by the Elder Board. Those nominated are two new candidates and five re-elected Elder positions. The new candidates are Jason Knap and Mike Miller. The re-elected candidates are Sam Ambalavanar, Harry Gibbs, Jonathon Huang, Sam Huey and Matthew Taylor. Sam reviewed the process for making nominations from the floor. There were no nominations from the floor. Election of Officers was done by ballot. All nominees received a majority of the votes as follow:
 - Sam Ambalavanar 159 votes
 - Harry Gibbs 150 votes
 - Jonathan Huang 154 votes
 - Sam Huey 92 votes
 - Jason Knapp 150 votes
 - Mike Miller 152 votes
 - Matthew Taylor 150 votes
